Specific migration of metals. Compliant to the European Directorate for the Quality of Medicines and Healthcare Technical guide PA/PH/EMB (13) 9 and Resolution CM/Res(2013)9, the product samples were not found to release any excess of heavy metals when subjected to a 0.5% citric acid test for 2 hours at a temperature of 70 °C.
